Her first desire was that Rama should be exiled to the forest for fourteen years, and the second, that her son, Bharat, be crowned as King. Dashrath was naturally heartbroken at the prospect of having to send his son into exile for fourteen years, but he reminded that honouring one's word is considered as the highest duty.

He didn't want that Rama should leave, but Rama reminded his father of the value of a promise given and left Ayodhya to keep his father's word. When Bharat begged Rama to return to Ayodhya, Rama once again reminded Bharat that he could not and would not dishonour his father by breaking the promise he had made to Kaikeyi.
